### OIC Call for proposals overview and analysis (Step 1 of the Project Cycle).

- Call was launched for OIC Project Concept Notes (PCN's) 14<sup>th</sup> August with a closing date 30<sup>th</sup> September, 2019.
- 26 PCN's received, see summary table. One WASH Global Hub established in Beirut.

#### **Key Outcomes:**

- Pledged Resources increased (from 20 M to over 60 M USD). Increased Government and other actors engagement at country level.
- 1 project per country and 'scaling-up' option during Project Cycle. Front loading of Project Resources from IFRC contributions.

#### **Observations & Recommendations:**

- Target population figures should demonstrate a clearer distinction between 'direct' and 'indirect' beneficiaries.
- Target populations will need to be better disaggregated (following SDG's, gender and age).
- Ensuring correct balance between humanitarian/development efforts, equal emphasis on WASH and Public Health components.
- External evaluation, verification and attribution guidance will be undertaken provided by external body.

## Further Developments/Next Steps:

- New 'One WASH' Baseline Tool basis for Detailed Proposals. (Multi-Language and Mobile Phone/Tablet versions).
- First Projects inception from July 2020. Seeking more country level partners.
- Resource Mobilisation Continues Sukuk Launch early 2020 Resource Target 200 M USD.
- Appointment of Independent Evaluation, Verification and Attribution Body.
- Pilots continue in Ghana; Uganda; Rwanda and Malawi.
- Global 'One WASH Hub' established in Beirut with additional staff, will grow further.
